 - Land Use
 - Crew was filling in drainage ditches and dumping dirt (corner of Beverly and Backlick, also on Auburn). Notified the crews that they need to have permits for any work done on property over 2200 SF. Forest permits needed for tree cutting as well

 - Parking blocking street and emergency vehicles
 - Call the police with any complaints need to build the record.

Member issues for discussion

- Sewer fees on water bill/\$800 for storm drainage/runoff fee are we double paying? Info was shared that even though Annandale Acres doesn't have sidewalks and storm drainage, these fees are paid by all county residents for the benefit of sidewalks and drainage on all major and minor roads. Sidewalks were offered to AA a number of years ago but were turned down by the neighborhood.
- Abandoned car issue can report it to the non-emergency number –
 they will run the tag, will run 30 day notice, when expired it can be
 put up for auction. Advise to first talk directly with neighbor then call
 if not resolved.
- Recent real estate sales in AA two homes that sold for \$550K and \$600K – sold within a day or a few days
- Status on Dominion burying main electric lines on Auburn and Beverly. These streets were selected as part of a plan from 2019 based on the number of outages. Mike Hilsher received notification they are relooking at it. All neighbors on the side where lines would be buried would need to agree. Some neighbors are concerned about right of way or boxes that must be set up every 4 houses. Also, with aging water lines running to private residences, will the county or Dominion pay if water line gets damaged? A resident asked if we could have a representative meet with the neighborhood? There was a meeting at Poe Elementary a couple years ago when the project was initiated. Mike Hilsher will contact Dominion to see if we can have a meeting of neighbors here.
